



he 9th National Conference of the Australian Infection Control Association Inc. (AICA) was held at the National Convention Centre, Canberra on 18-19 May. The Conference was well represented by all states and territories with 332 registrants from many diverse areas of the Health Care Industry. These included infection control practitioners, microbiologists, infectious disease physicians, general practitioners, dentists, dental assistants, and trade representatives. The trades were well represented by 44 excellent exhibitions. Lunches, morning and afternoon teas were served amongst the booths allowing maximum interaction of registrants with the representatives. AICA is very grateful to the trades for their commitment, representation and sponsorship. Without their continued support of infection control, the annual conferences would not have been as successful as has been demonstrated.

Apart from venue organisational hiccups and time constraint problems, the Steering Committee of the Infection Control Association ACT Inc, (ICA ACT) were happy with the Conference generally. As with all conferences, an important aspect for delegates and trade alike, is the networking. The National Conference Centre lends itself remarkably well to this function, with many positive comments and feedback having been received in this regard.

The Conference was opened by Professor Jennifer James, Head of School of Nursing Science, University of Canberra. Professor James highlighted the fact that on researching holdings, she found nine on virology, 384 on microbiology and only eight on infection control. Infection control practitioners need to be addressing such issues as we move towards the 21st century.

Professor Yvonne Cossart, Bosch Professor, Department of Infectious Diseases, University of Sydney was the Keynote Speaker and her paper was titled "Clean Hands Still Transmit Disease". Professor Cossart gave as an example from times past – and it is still relevant today – on how easily we can be fooled into thinking and believing something is clean, ie water and/or hands just because it/they look clean. We were reminded how dangerous this assumption can be.


Another Keynote Speaker was Professor Lyn Gilbert, Director of Clinical Microbiology, Institute of Clinical Pathology and Medical Research, Westmead Hospital Sydney and Clinical Professor, Department of Infectious Diseases, University of Sydney. Her paper was on "Group B Streptococcus". Dianne Dreimanis of Woden Valley Hospital presented Group B Streptococcus data collected from the ACT Hospitals during the past three years.

A third Keynote Speaker was Professor Peter McDonald, Head of Microbiology and Infectious Diseases at the Flinders Medical Centre, Adelaide who spoke on "Ethics and Infection Control" and highlighted the rapidly changing situation regarding collection and dissemination of data in the nineties.

The NSW Nosocomial Infection Outcome Indicator Project Team, of Cathryn Murphy, Drs Julian Gold, Mary-Louise McLaws and Peter Taylor led a panel on National Surveillance Towards the Year 2000. Other speakers on the panel were nominated representatives of Infection Control Associations from each state and territory. The issues addressed by the panel included:

- Reliability & validity in nosocomial surveillance
- Outback surveillance
- Surveillance from a private hospital perspective
- Trust, confidentiality and ownership of data
- Difficulties and benefits experienced in WA surveillance
- Interhospital comparison & risk stratification – how is it possible?
- Position paper on clinical indicators 5A and 5B of the ACHS Healthcare Standards Evaluation Programme
- How ACHS definitions work and don't work for Tasmania
- Establishing computer systems for surveillance
- The future of surveillance

The outcome of this panel discussion was expected to identify the diverse methods of collection, assessment and



Meg Winks, RN, State Co-ordinator, TB Services NSW Health Department outlined her role in education, case prevention, case finding, contact tracing, surveillance and evaluation services, drug projections and the monitoring of delays in diagnosis, notification and treatment. TB has taken a new perspective in the 1990s, requiring continued evolvement and development of strategies for its containment and control.

Dr Peter Collignon, Infectious Diseases Physician and Microbiologist, Woden Valley Hospital described a hospital-based prospective study on all patients with positive blood cultures associated with intravascular catheter sepsis. The incidence of significant sepsis was quoted as 8.1 episodes per 1000 admissions. The most common organisms isolated with Staphylococcus aureus (75 episodes) and E coli (70 episodes). Fifty patients died. 128 episodes were hospital acquired. The primary site of sepsis was intravenous catheters in 68 episodes, as well as renal tract (57 episodes), GIT tract (48 episodes), respiratory tract (25 episodes) and biliary tract (23 episodes). Nosocomial bacteraemia accounted for 40% of episodes. Half of these nosocomial infections were iatrogenic (IV catheters 68, renal 113, ERCP 1).

Elizabeth MacKinlay, Senior Lecturer Nursing Science, University of Canberra, presented a picture of common infections encountered in the elderly. She stated that frequently it is harder to recognise early signs of infection in the aged due to their other physiological disorders. Indeed signs of infection may be ignored, attributing them to "just part of growing older".

The conference finished on a high note with a selection of proffered papers on surveillance, paediatrics and reusing single use items.

A selection of these papers will be published in future issues.

ACHS and VICNA Seminar, March 1995: Infection Control: New Standards, Improved Quality

half day seminar at Royal Melbourne Hospital on 20 March 1995 by Australian Council of Healthcare Standards was one of several held around Australia over recent months. The seminar highlighted changes in emphasis and requirements of infection control for accreditation of hospitals in the future. Infection control, like quality assurance, is now recognised as a significant element, an essential safety component, in hospital processes today. Both the ACHS Service Manager and ACHS Surveyor emphasised the expectation of a high profile and priority for infection control, infiltrating all fields and divisions of the hospital. To assess this, staff, both at ground level (nurses, cleaners, etcetera) and management level (including senior management), will be interviewed and records examined (committee minutes and communication documents, for example). Priority would also be reflected in the resources allocated to the infection control programme. Expectations emphasised throughout the seminar are outlined as follows.

It must be demonstrated that the programme is effective, that there is evidence of proper surveillance, prevention and control of infection through planned activities with a proactive force. These activities must include all patient care and support services. Each health care worker must realise their defined role in preventing infection and this must be reflected in their job description.

The infection control committee is expected to be active in ensuring establishment of correct protocols through regular reviews and evaluation of work practices. The infection control co-ordinator is expected to be consulted for any related matters and be responsible for the supervision and implementation of infection control policies throughout the entire facility. S/he must conduct quality activities including surveillance of ME infections, hygiene practices and environmental maintenance. Reports to management and their subsequent responses will be examined.

The infection control realm includes infection prevention and control in general, sterilising and environmental services. The sterilising services must be managed by a properly qualified person. Correct sterilising processes, storage and distribution of sterile goods will be examined, as well as staff training and proper documentation of procedures. The cleaning/housekeeping service must be organised and assurance of a safe and healthy environment for patients demonstrated. Documentation must identify procedures and expected outcomes of cleaning procedures. A close working relationship between cleaning/housekeeping and infection control services is essential.

Other areas to be examined include procedures, monitoring and documentation related to the purchase, storage and use of chemicals, supply department, engineering, food services, pest control, purchase and maintenance of equipment and materials, linen, waste disposal, universal precautions, hand washing, sharps and blood

contamination injuries and support and education programmes. It was emphasised that it is the hospitals responsibility to ensure that the facility supplying linen is maintaining high standards.

Overall, the new guidelines are seen to broaden the role of the infection control practitioner through an increased profile in all areas of the hospital, being

involved in a wider cross section of policy development and procedure development and having a greater role in monitoring infection control

practices and infection rates. The practitioner plays a central role in evaluating practices to prevent and control infection and guiding changes to improve outcomes. This means more responsibility to be the expert and consultant, increased educational requirements and advanced evaluation/quality assurance skills.

Further into the future, accreditation overall will change significantly to focus more on continuum of care from patients' first arrival at hospital to community management. Through this process, the monitoring, evaluation and outcome of care is priority. The standards of processes and structures, as currently assessed, remains important, but the organisation and interaction of these, as opposed to the performance of individual departments, will be reviewed.

Medical and Dental Office Practice Infection Control Certification

The investigation of HIV transmission during minor surgical procedures in an office practice in New South Wales led to the conclusion that there must have been some breakdown in infection control procedures. The same conclusion had been reached in the USA during an investigation of HIV transmission relating to a dental practice conducted by an HIV-positive practitioner.

In response to these incidents, the South Australian Branches of the Australian Medical Association (AMA) and the Australian Dental Association (ADA) initiated the development of a process of certification of medical and dental practices for infection control procedures.

As President of the Infection Control Association of South Australia (ICASA) I was invited to join a working party with the AMA and ADA to develop these procedures. After some 12 months of deliberation appropriate procedures were developed and AMADA Quality Management was formed as a joint venture between the AMA and ADA to coordinate the certification process and to provide a form of self regulation.

The aim of the certification process is to ensure continuous quality improvement. Medical and dental practitioners are provided with support to analyse their procedures against a checklist, to educate themselves and their staff, and to maintain evidence of professional responsibility and public accountability. AMADA Quality Management was launched at a seminar in February 1995 and was attended by over 500 dental and medical practitioners, who were invited to undergo the certification process.

This process consists of a visit from an infection control practitioner and either a doctor or dentist who assess the practice according to a checklist covering the following:

- Cleanliness and the working environment
- Hand washing facilities
- Sharps and waste disposal
- Protective equipment
- Safe handling of laboratory items and pathology specimens
- Medication administration
- Equipment/instrument cleaning, disinfection, sterilisation and storage
- Staff education and training in infection control
- Policy development
- Quality management
- Vaccination of staff

A report is then presented to a certification committee consisting of two doctors and two dentists appointed by the AMA and ADA respectively. Finally certificates of compliance are issued for display in surgeries.

The Australian Dental Association (SA Branch) Director of Training for the Dental Assistant Training Course began planning a post basic course in Infection Control for country and metropolitan trainees. The response to the basic course was so great, over 50 people were turned away. A second course has been promised in the future.

 AMADA Quality Management presented papers and participated actively in panel discussions that were scheduled throughout the weekend.

Professor Peter McDonald discussed "Background Microbiology – Transmission of Disease Virulence" or micro-organisms.

Of Special interest was a talk by Dr Liz Coates from the Adelaide Dental Hospital Extended Dental Care Clinic on "The Management of Patients with Infectious Diseases" (with emphasis on HIV).

Subject areas particular to Dentistry were addressed in short presentations:

Disposal of Dental Waste Waste Management Regulations

Sterilising Research and Advisory Council of Australia (SA Branch) member, Violet Letford (The Queen Elizabeth Hospital Central Sterilising Services Department) spoke on Instrument Sterilisation. The ensuing Panel Presentation was lively addressing Surgery Layout and Design, Daily Work Practices, Surgery Cleaning and Decontamination Procedures. Questions from the floor were answered by the appropriate fields and disciplines.

Instrument Sterilisation, Packaging and Storage of Instruments, Autoclave Use and Maintenance, Calibration and Monitoring drew a lot of attention, as did the General Cleaning of the Clinic Area – the use of <u>only</u> detergent and water for general surface cleaning recurred for discussion regularly throughout the weekend.

Media interest focussed on the sterilisation of equipment, particularly dental drill handpieces, and the positive attitude of the large audience to effecting changes throughout the dental work area and private practices.

Evaluation of the weekend was positive and provided valuable information for Dentists and Dental Staff who are planning to seek Practise Accreditation.

He has written a book on microbiology for medical students which is soon to be released and is working on a CD Rom programme for infection

At the conclusion of the course, the students will undertake projects at Fremantle Hospital as well as attend further lectures and workshops before returning to their countries.
