From the President's Desk

An exciting time ahead for the Association

In May, the AICA Executive met for a 2-day face-to-face meeting in Brisbane and tackled some challenging issues on the agenda. Shortly all AICA members will receive correspondence about proposed changes to AICA's existing structure and how these changes will affect you as a member. In the months leading up to the National Annual General Meeting (AGM) which will be held in Perth on October 5th 2010, you will be asked to consider the information carefully and to vote at the AGM with a motion of support for the proposed changes. For some time the Executive has recognised that change is critical to the growth and success of AICA in providing a unified national voice for infection control professionals. By improving access and services available to members, we aim to strengthen our profession and to improve health outcomes for patients. In the last 2 years, AICA has experienced a surge in requests to represent our members in a growing number of national forums and we have exceeded our current capacity. AICA is also experiencing internal expansion and there are major projects scheduled in the coming months (highlighted on page 5).

Our ability to move swiftly and collaboratively is demonstrated by the release of a timely AICA position paper on the hypervirulent strain of *clostridium difficile* (available from the AICA website). Our ability to be responsive and proactive is essential as we strengthen our National profile with our external partners and we are called on to provide expert opinion and feedback in public forums.

AICA is proposing a change of structure from a State based organisation with a State and Territory membership base to a National membership with elected S/T representation. Such a change will enable more efficient service provision and enhance communication to members. AICA will continue to have a strong national voice, which will extend to other activities at an international level but there will be increased buy in at a grass roots level. The change will not affect your day-to-day job; however, it will improve communication with you as a member by increasing availability and access to resources and opportunities available for research and development.

AICA has engaged and external company to assist us during this time of transition. Following a baseline assessment AICA will be able to provide more detailed information about the proposed changes and the way forward. We are seeking endorsement and support from all members to enable this to happen.

Fifth Decennial International Conference on Healthcare-Associated Infections 2010

The Florence Nightingale Leadership Grant was awarded to Anne Wells by the Tasmanian Returned Nurses Memorial Trust in 2009. The grant enabled Anne to attend this conference during March. (Anne would like to acknowledge Saffron Brown who was a co-recipient of the grant but not able to attend the conference.) The conference was held in Atlanta, Georgia and was attended by almost 3000 international delegates. This forum provided an exceptional opportunity for hearing the latest infection prevention related studies and first–hand interaction with peers, researchers and experts from around the world.

Among the sessions Anne attended was Preventing Central-Line Associated BSI, Infection Control and the Healthcare Environment, Controversies in Contact Precautions, Infection Prevention and Control in Non-Acute Settings and The Most Influential Publications of the Last Decade.

Of particular interest was a presentation by Dr Philip Carling which addressed the challenges of achieving sustained improvement in environmental hygiene. A number of presentations addressed the effectiveness of new technologies for disinfection such as the use of ultra violet light.

Anne will present a summary of her conference experience at a future TICA meeting and other infection control educational events.


AICAlist
