In addition, papers are vigorously reviewed and edited by the editorial board. Nonetheless, the views put by authors are their own and do not necessarily reflect those of the editors or the Publisher.

COPYRIGHT

Submission of a paper to *Pacific Conservation Biology* will be taken to imply that it presents original unpublished work, not under consideration for publication elsewhere. By submitting a manuscript, the authors agree that the copyright for their article is transferred to the Publisher if and when the article is accepted for publication. The copyright covers the exclusive rights to reproduce and distribute the article, including reprints, photographic reproductions, microfilm or any other reproductions of similar nature, and translations. Permission to publish illustrations must be obtained by the author before submission and any acknowledgements should be included in the captions.

Authors of papers in *Pacific Conservation Biology* should be subscribers to the journal. The Editor-in-Chief will ask whether any of the authors is a subscriber when confirming acceptance of a paper. If one or more authors is a subscriber, there will be no charge for publication, unless the authors have agreed to pay the charges for colour or accelerated publication (see below). If no author subscribes, the corresponding author will be invoiced a flat publication fee of Aud\$100, plus and charges for colour or accelerated publication (see below). Whether or not one or more authors subscribes has no bearing on the acceptance of a paper. Authors may choose to include colour figures in their papers at a cost of Aud\$150 per page with a colour component. Authors may also accelerate publication to the next available issue without penalty to other authors by paying full page charges of AUD\$65 per page.

Conservation and Decline of Amphibians:
Ecological Aspects, Effect of Humans and Management

THE late 20th century and the early 21st century has been characterized by an unprecedented deterioration of the environment of the earth and the throes of one of the major extinction events of all time. New diseases have emerged. Unmitigated deforestation, desertization, erosion and salinization of soil, pollution of water and air, and thinning of the UV-protective ozone layer constitute dire ecological threats for life on the planet. Fossil carbon is being returned to the atmosphere at an accelerated rate with a concomitant change in the earth's climate that is likely to make serious inroads into ecological stability.

The present volume (10) treats (1) the roles of anthropogenic influences such as habitat change; introduction of alien species; roadkills; direct harvesting, trade, and use of amphibian species by humans; (2) various ecological, phylogenetic, and geographic correlates of amphibian decline, (3) monitoring programs and conservation practices such as establishment of refugia; and captive breeding and re-introduction.
